## WMBX - X 102.3 Black Music Month Sweepstakes

## **Official Rules**

## BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. **Eligibility:** The WMBX X102.3 Black Music Month Sweepstakes (the "Sweepstakes") is open only to individuals who are 18 years and residents of Florida and who reside within 150 miles of Hubbard Radio West Palm Beach's studio located at 701 Northpoint Parkway, Suite 500, West Palm Beach, FL 33407, to be eligible to win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Once submitted you will receive one (1) entry into the random drawing. Limit one (1) entry per person. All entries must be received by 11:59:59 PM ET on 6/30/2022, to be entered into the final random drawing.
  - In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed to be submitted by the person in whose name the email account is registered. The entrant may be required to provide evidence that the entrant is the authorized account holder of the email account associated with the winning entry and complete an affidavit and/or any applicable releases. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries, which may be disqualified.
