

WMBX - X 102.3 Win Steve Harvey's Money Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility:** The WMBX X102.3 Win Steve Harvey's Money Sweepstakes (the "Sweepstakes") is open only to individuals who are 18 years and residents of Florida and who reside within 150 miles of Hubbard Radio West Palm Beach's studio located at 701 Northpoint Parkway, Suite 500, West Palm Beach, FL 33407, to be eligible to win. No purchase necessary to enter the Sweepstakes. Employees of Hubbard Radio West Palm Beach, LLC and its radio station X102.3 (the "Sponsor"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Sweepstakes Period:** The Sweepstakes will start at 8:00:00 AM Eastern Time ("ET") on June 1, 2022 and will end at 2:59:59 PM ET on June 30, 2022 (the "Sweepstakes Period").
- 3. How to Enter:** To enter, you must download the WMBX X102.3 mobile Stream Player app (the "App") from your App marketplace to your iPhone, iPad or Android device, and open the App on your smartphone or iPad or tablet. Upon opening the App, you must register to be an App Rewards Member by visiting the Sponsor's website at www.X1023.com. Once you become an App Rewards Member, or if you were already an App Rewards member before this Sweepstakes, open your App during the Sweepstakes Period to find the Sweepstakes tile to enter and submit your name to receive an entry into the random drawing. Limit one (1) entry per App Rewards Member per day. All entries/registrations must be received by 2:59:59 PM ET on 6/30/2022, to be entered into the random drawing.

In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed to be submitted by the person in whose name the email account is registered. The entrant may be required to provide evidence that the entrant is the authorized account holder of the email account associated with the winning entry and complete an affidavit and/or any applicable releases. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries, which may be disqualified. Any attempt by any participant to enter by using multiple/different identities, or any other methods may disqualify that participant from winning any prize, at the sole discretion of Sponsor.

- 4. How winner is determined:** One (1) Grand Prize winner will be selected in four (4) separate random drawings from among all eligible entries received up to that random drawing date. The random drawings will occur on June 10, 2022, June 17, 2022, June 24, 2022 and July 1, 2022 at or about 3:00 PM ET. Each random drawing will be conducted by Sponsor. Decisions of Sponsor are final and binding. All non-winning entries from any random drawing WILL roll over to subsequent random drawings. Odds of winning a Grand Prize depend on the total number of eligible entries received up until each random drawing. The Grand Prize winners will be notified by telephone/email on or about the day of the applicable random drawing. Sponsor will make **2 attempts** to reach each potential Grand Prize winner. In the event a potential Grand Prize winner cannot be reached by Sponsor after **2 attempts**,

he/she forfeits his/her right to the Grand Prize, and an alternate may be selected, time permitting, at Sponsor's sole discretion.

5. **Prizes and Approximate Retail Values ("ARV") – Four (4) Grand Prizes** – \$500.00, awarded in the form of a check to the Grand Prize winner. ARV: \$500.00 each. Total ARV of all prizes is \$2,000.00.

Prize consists of only those items specifically listed as part of the Prize. The Prize will be awarded only if the potential Prize winner that fully complies with these Official Rules. Failure to comply with this deadline shall be deemed to be the winner's forfeiture of his or her right to claim the Prize. The winner must prove he or she is a qualified winner by presenting acceptable identification (e.g., state driver's license; state issued identification card; valid passport with address verification; or birth certificate with social security card and photo identification and address verification).

7. **Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
